

## Good work for the month of September 2019.

### **1. PERNEM PS CR. NO. 154/2019 U/S 302, 120-B IPC**

On 19.09.2019, Tanu Rai s/o Jogesh Rai, age 20 yrs, N/o West Bengal, presently residing at Gawdewada, Morjim Goa, complained that on 19.09.2019 at about 00.15 hrs at Ashwem Mandrem, Pernem Goa, accused persons namely 1) Dalim s/o Jatin Rai, age 26 yrs, 2) Bappi s/o Kalindhirav Mondal, age 26 yrs, 3) Raj Kumar full name not known all N/o West Bengal, presently residing at Gawdewada, Morjim Goa on previous enmity over business rivalry hatched a criminal conspiracy and assaulted the deceased Chiranjit Rai brother of the complainant and victim Anand Barman causing serious injuries on their stomach with some sharp weapon and committed murder of the complainant's brother namely Chiranjit Rai.

Accused Bappi s/o Kalindhirav Mondal, age 26 yrs, was arrested on 19.09.2019 at 23.54 hrs, after observing Supreme Court guidelines.

### **2. CALANGUTE PS CR. NO. 183/2019 U/S 489-A, 489-B, 489-C, 489-E IPC.**

On 15.09.2019, Smt. Dhanashri Manerikar, Branch Head, EC-628891, IDBI Bank, Candolim Branch, Candolim Bardez Goa, complained that on 10.09.2019 TNK at IDBI Bank, Candolim Bardez Goa, accused Mohanlal s/o Meharsing, age 28 yrs, c/o Sanjeev Shiroadkar, near Nagoa Circle, Nagoa Bardez, N/o Saras, Pehow, Kurukshetar, Haryana, holder of Account No. 1615104000015145 of IDBI Bank, Candolim Branch, counterfeit Indian Currency notes, kept in possession and used the same as genuine Indian Currency notes to deceive the Bank officials and deposited 156 counterfeit Indian Currency notes in denomination of Rs. 200/-, Rs. 100/- and Rs. 50/-total amounting to Rs. 15,150/-.

Accused Mohanlal s/o Meharsing, age 28 yrs, c/o Sanjeev Shiroadkar, near Nagoa Circle, Nagoa Bardez, N/o Saras, Pehow, Kurukshetar, Haryana was arrested on 15.09.2019 at 21.15 hrs, after observing Supreme Court guidelines.

### **3. PANAJI P.S. CR. NO. 206/2019 U/S 20 (B) (II) (A) OF NDPS ACT**

On 05.09.2019, Shri Rahul Naik, PSI, Panaji Police Station complained that on 05.09.2019 between 19.25 hrs to 21.30 hrs at near DR ground, Campal Panaji Goa, the personal search of accused Hanumant s/o Shivappa Karbimanna, age 32 yrs, r/o c/o Malik Kadroli, Near Kitchen Classic Hotel, Kevnem Taleigao, Tiswadi Goa, was taken during which he was found in illegal possession of illegal Narcotic Drugs suspected to be Ganja weighing 180 grams W/Rs. 36,000/- approx. **7. MAPUSA P.S. CR. NO. 210/2019 U/S 451, 354, 376, 506 (II) IPC & SEC 8 OF GOA CHILDREN'S ACT & SEC 6, 8 OF POCSO ACT**

On 05.09.2019, upon complained that between 14<sup>th</sup> March 2019 to August 2019 at H. No. 25, Acoi, Mapusa Bardez Goa, accused Surjit Ganguly, who is the swimming coach of the complainant's minor daughter, age 15 yrs, by taking advantage of his position as coach, criminally trespassed into complainants residential premises, hold and touched her private parts, molested her and further threatened her with dire consequences if she disclosed the incident to anyone. I.O. visited the scene of offence and conducted detail scene of offence panchanama. Accused has been arrested.

**8. PORVORIM P.S. CR. NO. 106/2019 U/S 20 (B) (II) (A) OF NDPS ACT.**

On 30.08.2019, Shri Prashal P.N.
