### Good work for the month of April 2017

#### 1. Panaji PS Cr. No. 86/2017 U/s 4 & 5 of ITP Act and section 370 of IPC:

On 21/04/2017, upon the state complaint of Shri Siddhant Shirodkar, PI Panaji PS lodged complaint to the effect that on 21/04/2017 between 19:15 hrs to 21:30 hrs at near Hotel La Campal Panaji Goa accused lady namely 1) Mrs Ruksar W/o MD Danish, Age 21 years, R/o D-124, Gali No. 4, D Block Ram Colony Delhi and Surya having mobile no. 9879615779 (Full details not known) procured girls from other state and supplying them to prospective customers over mobile phone no. 8796157729 and accused at Sr. no. 1 was caught red handed while delivering the girls for the purpose of prostitution and living on their earnings. One victim girl namely Miss Aprajita D/ Rajesh Verma, Age-21 years, R/o N/o Sector 75 Mohali 382, near SS Nagar Punjab is rescued during the raid and is subsequently lodged in Protective Home, Merces for care and protection. Accused lady namely Mrs Ruksar W/o MD Danish, Age 21 years, R/o D-124, Gali No. 4, D Block Ram Colony Delhi arrested on 21/04/2017 at 22:10 hrs. Further investigation is in progress.

## 2. Panaji PS Cr. No. 91/2017 U/s 20(b)(ii)(A) of NDPS Act:

That on 27/04/2017 between 21:15 hrs to 23:15 hrs, upon reliable & specific information, narcotic raid was conducted inside garden in front of Collectorate building Tiswadi, Panaji-Goa and accused namely Venkatesh S/o Tirumalaya Kotta, Age-20 years, Occ- driver, R/o Flat No. A38, GRP Quarters, Althinho Panaji Goa, was found in possession of illegal narcotics drugs i.e. Ganja weighing 40 grams W/Rs 5000/- approximately. Accused person namely Venkatesh S/o Tirumalaya Kotta, Age-20 years, Occ- driver, R/o Flat No. A38, GRP Quarters, Althinho Panaji Goa, arrested on 27/04/2017 at 23:50 hrs. Further investigation is in progress

#### 3. Mapusa PS Cr. No. 166/2017 U/s 21(b) and 22(b) of NDPS Act:

That on 18/04/2017, between 22:30 hrs to 01:40 hrs of 19/04/2017, upon reliable & specific information, narcotic raid was conducted at near Galaxy Hospital Xelpem Duler Mapusa Bardez-Goa, accused person Ferdinand Chukwudi Joseph, age-34 years, Nigerian National was caught red handed for being in illegal possession of 40.3 grams of white powder substance suspected to be cocaine (W/Rs. 201500/-) and 8.3 grams of brownish colour crystal substance suspected to be MDMA (Rs. 83,000/-) all W/Rs. 2,84,500/-approximately. Seized drugs along with other related articles has been attached under panchanama. Accused Ferdinand Chukwudi Joseph, age-34 years, Nigerian National has been arrested.

# 4. Pernem PS Cr. No. 71/2017 U/s 20 (b) (ii) (A) of NDPS Act, 1985:

That on 15/04/2017 between 22:30 hrs to 00:45 hrs of 16/04/2017, upon reliable & specific information, narcotic raid was conducted infront of Opinal Shack, Arambol Pernem Goa and on personal search of accused namely Mr. Kalpesh S/o Aditi Prasad Dwivedi Age-23 years, at present R/o C/o For You Restaurant, sweet lake, Arambol, Pernem Goa, N/o Village Chavvar, Tehsil- Devsar, District Shingroli, Madhya Pradesh was taken and during which he was found in possession of iilegal narcotic drugs i.e. Ganja weighted 164 grams W/Rs. 6000/- approximately which has been attached under the panchanama. The accused person Kalpesh S/o Aditi Prasad Dwivedi Age-23 years, At present R/o C/o For You Restaurant, sweet lake, Arambol, Pernem Goa, N/o Village Chavvar, Tehsil- Devsar, District Shingroli, Madhya Pradesh arrested on 16/04/2017 at 02:30 hrs.

# 5. Calangute Police station Cr. No. 68/17 u/s 20(b)(ii)(A) of NDPS Act:

That on 21.04.17 between 21.50 hrs to 00.50 hrs of 22.04.2017, upon reliable & specific information, narcotic raid was conducted at Candolim beach and caught red handed accused sunny ugrejiya s/o Chandu Ugrejiya, age-21 yrs r/o Vaddy, Candolim n/o Muli, Surendranagar, Gujrat with an illegal possession of 14 grams of Ganja w/Rs.1500/-and 35 grams of charas w/Rs 3500/- all w/Rs.5000/- approximately. Accused arrested and kept in Police Custody.

# 6. Calangute Police Station 58/2017 u/s 370, 370 (3), 370-A, 420 r/w 34 IPC, Sec 4, 5 & 7 of Immoral Traffic (Prevention) Act. & Sec 8 (2) of Goa Children's Act & Sec 8 of POCSO Act.

On 08.04.2017 between 21.30 hrs to 23.30 hrs, upon a reliable and specific information a raid was conducted at near Hotel Sinq Signature, Naikawada, Calangute and during the raid two girls aged 16 and 25 yrs, were rescued who were procured by the accused persons namely 1) Uttam Bhamari Behera, age 24 yrs, r/o Machajana, Post-Oskana, Dist-Jagatsinghpur PS, Dasabatia Odisha, 2) Deepkumar s/o H.R. Verma, age 41 yrs, r/o Sector-21, Gurgao, Haryana and 3) Prasad s/o Vaidhyanath Vaidhyanathan, age 42 yrs, r/o Sector-10, Gurgao, Haryana, for the purpose of prostitution. Accused Uttam Bhamari Behera was found living on the earnings of the prostitution in the vicinity of the public place. Also accused Uttam Bhamari Behera had handed over the Voters Identity card in the name of Madhu Saraja Kavate, age 28 yrs to the rescued minor victim girl to conceal her actual name, identity and age for the purpose of cheating.

All accused persons were arrested on 09.04.2017 at 00.45 hrs after observing Supreme Court guidelines.

# 7. Calangute Police station CR. No. 65/2017 U/s 20(b) (ii) (A) of NDPS Act

That on 15.04.17 between 23.15 to 01.00 hrs of 16.04.17, upon reliable & specific information, narcotic raid was conducted at pay parking, Baga Calangute and upon personel search of shiv dayal s/o pritam Singh, aghe-22 yrs r/o Baga, Calangute n/o shilh, Tung, Kullu, Himachal Pradesh was taken and during which he was found having in possession illegal drugs ganja weighing 19 grms w/Rs. 2000/- and charas weighing 62 grams w/Rs. 7000/- all w/Rs. 9000/- approximately. Accused arrested and lodged in PC. Case is under investigation.

8. Anjuna PS Cr. No. 44/17 u/s 420 r/w 34 IPC & Sec. 3 & 4 of Goa Public Gambling Act.

On 17/04/2017, between 17.30 hrs to 23.30 hrs, upon reliable & specific information a raid was conducted by staff of District Investigation Unit & Anjuna PS, at A-1, Casa Del Sol, Gaowadi, Anjuna, Bardez-Goa and accused persons 1) Mr. Kiransinh s/o Harishasinh Vaghela, 2) Mr. Jayanti s/o Shivlal Vaghela both r/o Vejalpur, Ahmadabad, Guijrat and 3) Mr. Narendra Singh s/o Dattaram Yadav r/o Jaitapur Kalo, Agra, Uttar Pradesh, who with their common intension were carrying out gambling activities in close room of a flat and were caught red handed while carrying activities by accepting bets on IPL match between Delhi Daredevils and Kolkata Knight Riders from betters by using laptop & Mobiles and were cheating the betters. Durring raid seized cash of Rs. 15,270/-, two laptops, 11 mobiles, LED Tv, Set top Box & other articles. Accused persons placed under arrest and released on Bail.
