### Good work for the month of January 2017

## 1. BICHOLIM P.S. CR. NO. 04/2017 U/S 302, 201 R/W 34 IPC.

On 11.01.2017, Mr. Gurudas Arjun Parwar, r/o Gaonkarwada, Narva Bicholim, complained that on 07.01.2017 at 21.00 hrs to 10.01.2017 at 13.22 hrs at TNK near Narva "T" junction, Gaonkarwada, Narva Bicholim Goa, accused namely 1) Suraj Dasharath Asbe, age 20 yrs, r/o Gaonkarwada, Bicholim and 2) Mr. Ganesh @ Gauresh Ramchandra Rawal, age 33 yrs, r/o Talwada, Narva, Bicholim, being friend of complainant's son, with their common intention, committed murder of his minor son namely Satish Gurudas Parwar, age 17 yrs, by assaulting him with laterite stone on his head and thereafter concealed dead body into the culvert.

Accused Suraj Dasharath Asbe, age 20 yrs and Mr. Ganesh @ Gauresh Ramchandra Rawal, age 33 yrs have been arrested in the above crime.

#### 2. Saligao PS Cr. No. 01/2017 u/s 380 IPC.

On 04/01/2017, upon complaint of Shri Surendra Kumar r/o Behind Gautam Hotel, Sangold, to the effect that between 23.15 of 30/12/2016 to 09.30 hrs of 31/12/2016, unknown person open his rented room and committed theft of Samsung Galaxy j1 White colour mobile phone and one lava mobile.

Accused Mahesh Bhat s/o Ganesh Datta Bhat r/o Mahendra Nager Nimbhudha, Kanchanpur, Nepal has been arrested and Samsung Galaxy j1 White colour mobile phone worth Rs. 8,500/- and one lava mobile worth Rs. 4,800/- has been recovered from accused.

#### 3. PANAJI P.S. CR. NO. 02/2017 U/S 20 (B) (II) (A) OF NDPS ACT.

On 03.01.2017 at 18.35 hrs, Shri.
