## 1. Anjuna P.S. Cr. No. 26/2017 U/s 20 (b) (ii) (A) of NDPS Act,

On 27.03.2017 a raid was conducted between 16.05. hrs to 18.40 hrs near Shri. Ghatageswar and Kashi Rammes Ghumti, Deulwada, Vagator, Goa, during the personal search of accused Mr. Basavraj s/o Kallappa Angadi, age 58 yrs r/o Village- Kolvi, Taluka- Gokak, Dist- Belgaum, Karnataka at present r/o c/o Mrs. Sushila Shirodkar r/o Zorwado, Chapora, Anjuna, Bardez Goa was carried out and during which he was found having in possession of 35.5 grams of Narcotic drug suspected to be Charas W/Rs. 20,000/-.
