## 1. Old Goa P.S. Cr. No. 47/2016 u/s 302 IPC & Sec 8 (2) of Goa Children's Act.

On 20.04.2016, Smt. Santradevi w/o Harbansh Mahto, n/o Aurangabad, Bihar presently residing at Old Goa, Tiswadi complained that on 20.04.2016 between 04.00 hrs to 06.00 hrs at Dhauji, Old Goa Tiswadi, accused Harbansh Mahto, age 35 yrs, n/o Aurangabad, Bihar, r/o Dhauji, Old Goa, committed murder of his minor daughter Miss Chandni Kumari, age 01 yrs, by compressing her neck.

Accused has been arrested.

# 2. Anjuna P.S. Cr. No. 36/2016 u/s 307, 120-B IPC & Sec 3 r/w 27 of Arms Act

On 11.04.2016, Shri Surendra Sazu Govekar, age 49 yrs, r/o Saurantowado, Anjuna complained that on 11.04.2016 at 19.10 hrs near St. Micheal School, Vagator Anjuna, while he was proceeding towards Anjuna in his Maruti 800 car bearing No. GA-01-R-5791, two unknown accused persons on a two wheeler details not known, fired bullet on him which hit on the his car on driver side door while in motion, however the bullet penetrated from front side door of the car with intention to shoot him thereby attempted to commit his murder.

During the course of investigation accused Gajendra @Chottu s/o Ratan Singh r/o Deulwada, Vagator has been arrested.

On 31.03.2016, Shri Tushar Digambar Govekar, age 26 yrs, Production Incharge of Alfagum Coating Solution Pvt. On 20.04.2016 at about 15.45 hrs near Govt. On 25.04.2016 between 20.45 hrs to 22.10 hrs near Chances Casino Donapaula accused Arush @ Ayush Kumar procured girls from other states, detained at Porvorim and supplying them to prospective customers through accused Santa Bahadur Chetri s/o Him Bahadur Chetri r/o Porvorim n/o Nepal who was caught red handed while delivering the girls for prostitution and are living on their earnings.

Three victim girls are rescued during the raid and are lodged in Protective Home Merces for care and protection. Accused has been arrested.

#### 9. Mapusa P.S. Cr. No. 122/2016 U/s 379 IPC

On 26.04.2016, Mr. Bherram s/o Devaram Kumavat r/o Sirsaim complained that on 10.04.2016 after 23.00 hrs to 07.00 hrs on 11.04.2016 some unknown person stole away complainant's Honda Activa bearing No. GA-04-A-4507 W/Rs. 20,000/- which was parked in an open parking place.

During the course of investigation, accused Yogesh Yeshwant Naik r/o Ganeshnagar, Assonora has been arrested and one juvenile has lodged in Apna Ghar Merces for care and protection. Also the stolen Scooter No. GA-04-A-4507 has been recovered at the instance of the accused.

# 11. Mapusa P.S. Cr. No. 123/2016 U/s 7 (1) (3) of Passport Order 1948, Sec 14 of Foreigner Act 1946 & Sec 3 (2) (a), 6 (a) of Passport Entry into India.

On 27.04.2016 at 19.20 hrs near St. Anna Church Parra accused Philip Ezekiel Ugochuknw, age 35 yrs, Nigerian National, presently residing at Assagao, having P.P. No. AO1712810 issued by Festac Lagos on 16/10/2013 V.T. 15/10/2018, was found staying in Goa/ India without legal permission i.e Visa to stay in Goa/ India.

Accused has been arrested.
