

## Good work for the month of February 2016

### 1. Pernem P.S. Cr. No. 16/2016 U/s 22 (i) (21) (a) of NDPS Act.

On 30.01.2016 between 21.10 hrs to 23.30 hrs near Simeshwar Temple, Khalchawada, Arombol, Pernem accused Mr. Mike Smith, age 35 yrs, Nigerian National, presently residing at Dando, Arombol, having P.P. No. A03446985 was caught red handed possessing illegal Narcotic drug suspected to be LSD Papers weighing 0.3 grams, W/Rs. 70,000/- and 1.5 grams of Cocaine W/Rs. 10,000/-.

Accused has been arrested.

### 2. Old Goa P.S. Cr. No. 15/2016 U/s 457, 380 r/w 34 IPC

On 03.02.2016, Sujit Pyarelal Patel r/o c/o John Alfonso, Corlim n/o Bihar complained that on 20.10.2015 at 21.00 hrs to 21.10.2015 at 06.00 hrs at Corlim accused 1) Zibral Khan & 2) Sayyed Javed Khan with their common intention effected entry into shop situated at opposite Sygenta factory styled as "Sugit Tea Stall" Corlim by break opening main door lock and committed theft of three empty gas cylinder of HP company and coin of Rs. 200/- from the cash drawer belongs to complainant all W/Rs. 9,200/- approximately.

Accused has been arrested in Old Goa PS Cr. No. 13/2016 u/s 454, 457, 380 r/w 34 IPC and the stolen property i.e. three HP cylinder in this Crime have been recovered.

### 3. Bicholim P.S. Cr. No. 21/2016 U/s 11 of Prevention of Cruelty to Animal Act, 1960, Rule 4 under Prevention of Cruelty to Animal Act, Rule 47 (a) of Transport of Animal Act 1978.

On 11.02.2016, Shri Amrutlal Singh, Member of Animal Rescue Squad Goa, r/o Bicholim complained that on 10.02.2016 at 23.55 hrs at Narve Bicholim accused 1) Mr. Kwazamiya Budansab (Driver) r/o Haveri Karnataka, 2) Mr. Basavraj Khanappa Bhavikatti (Purchaser) r/o Gadag Karnataka and 3) Mr. Dattaram Masu Naik (Seller) r/o Murdiwada, Narva Bicholim, caught red handed with one truck No. KA-22-C-2122 boarding cattle's i.e 02 Cows, 04 Calf's and 02Bulls while transporting the same from Narve village to Karnataka state without valid documents from the competent authority.

Accused Kwazamiya Budansab and Basavraj Khanappa Bhavikatti were arrested.



**4. Calangute P.S. Cr. No. 20/2016 u/s 370 IPC & Swec 4, 5 & 7 of Immoral Traffic (Prevention) Act, 1956.**

On 12.02.2016 between 20.00 hrs to 21.30 hrs upon specific information a raid was conducted near KFC, Naikawada, Calangute and during the raid one female victim n/o Mumbai was rescued who was procured by the accused Padam Bahadur s/o Yam Chetry, age 29 yrs, n/o Kassipur, Udalguri, Assam and was brought her near KFC, Naikawada Calangute for supplying her to the customers for the purpose of prostitution and accused was found living on the earning of prostitution in the vicinity of public place.

Accused has been arrested and the rescued victim girl has lodged in Apna Ghar Mercedes for her protection and safety.

**5. Anjuna P.S. Cr. No. 20/2016 u/s 20(b)(ii)(A) of NDPS Act.**

That on 13/02/2016 at 23.25 hrs PSI Arun Bakre of Anjuna P.S. complaint on behalf of state that on 13/02/2016 between 19.45 hrs to 22.35 hrs at Onechebhat Anjuna near Village Panchayat accused person namely Alsted D'Silva, R/o Cochin Kerala found having in position of 622 gram of Narcotic drugs known as Ganja illegally W/Rs. 60,200/- and same is seized under panchanama along with other exhibits. Accused arrested and placed in police custody.

**6. Calangute P.S. Cr. No. 24/2016 u/s 427, 379 IPC**

On 15.02.2016, Shri Rupesh Ramdas Naik, r/o Mala Portais, Panaji complained that on 26.01.2016 at 02.30 hrs accused Shankesh Laxman Chodankar, age 21 yrs, r/o Porbhawado, Calangute caused damaged to his vehicle Swift No. GA-07-E-4389 & committed theft of 1) Mac book Air Laptop, 2) Beast white studio head phone, 3) Gapro Hero-3- Camera, 4) Oakley sunglass, 5) cash of Rs. 20,000/-, all W/Rs. 1,00,000/- from his vehicle.

Accused has been arrested.

**7. Calangute P.S. Cr. No. 28/2016 u/s 302 IPC**

On 25.02.2016, Dipankar Guha s/o late D.C. Guha, General Manager of Hotel Cygnett Inn Celestial, Ximer Candolim complained that on 25.02.2016 at about 02.16 hrs, unknown person came to the reception of the Hotel Cygnett Inn Celestial and assaulted the receptionist namely George Raju Mandal n/o Kolkatta with knife causing him serious injuries resulting in his death.

During the course of investigation, accused Manjit s/o Jagdish Tomar, age 23 yrs, r/o H. No. 608, Gorad, Kharkhuda, Sonipat, Haryana has been arrested.

**8. Porvorim P.S. Cr.No. 21/2015 u/s 4, 5 & 7 of Immoral Traffic (Prevention) Act. 1956 and Sec 370 IPC**

On 26.02.2016 between 19.30 hrs to 22.00 hrs upon specific and reliable information a prostitution raid was conducted at NH-17 highway road proceeding from Panaji to Mapusa, near Gauri Petrol Pump, Porvorim, wherein three victim girls was procured by accused 1) PravinParab r/o Kads, MopaPernem presently residing at near Paulo Garage, District Hospital road, Mapusa, and 2) Mrs. Pragati w/o PravinParab @ Sufiya, n/o Mumbai Maharashtra presently residing at near Paulo Garage, District Hospital road, Mapusa in order to deliver them to the prospective customers for the purpose of prostitution and were found living on the earnings of the victim girls earned through the prostitution.

Both accused were arrested and the victim girls have been lodge at Protective Home for their protection and safety.
