

Good work for the month of January 2016

1. Mapusa P.S. Cr. No. 23/2016 U/S 21 (b) of NDPS Act

On 15.01.2016 at about 19.50 hrs to 21.45 hrs at football ground Parra accused Mr. Ogbanna Okoro Sunday, age 32 yrs, Nigerian National, P.P. No. A02959985 r/o Anjuna was caught red handed and seized from his possession Narcotics drugs i.e. Cocaine weighing 14 grams W/Rs. 70,000/-.

Accused has been arrested.

2. Old Goa P.S. Cr. No. 13/2016 u/s 454, 457, 380 R/w 34 IPC

On 30.01.2016 at 14.50 hrs, Shri Pradeep Sitaram Satardekar, Manager r/o Sangolda complained that since November 2016 to 30.01.2016 at 11.00 hrs at Total Packaging Factory situated at plot No. 4/A, 4/B Corlim IDC, accused 1) Sunil Dodamanni s/o Basuraj age 18 yrs c/o Suresh Dodamanni, Corlim n/o Bagalkot Karnataka, 2) Sayad Khan s/o Javed aged 23 yrs r/o PDA Colony, Corlim n/o Karmali, Bhoma, Ponda, 3) Laudum Goyary s/o Sontla Goyary aged 24 yrs r/o Dhulapi c/o Prakash n/o Assam and 4) Jibrai Khan s/o Nabi Hussain Khan aged 25 yrs r/o c/o Shailesh Dhulapi Ilhas n/o U.P. District with their common intention effected entry into the factory by break opening the door of factory shed and committed theft of 1) motor of Pulveriser machine of 10 H.P. 1 nos. , 2) Blending machine motor of 15 H.P. 1 nos., 3) sewing machine motor 01 nos., 4) feeding machine motor 10 H.P.1 nos., 5) 1 H.P. motor 3 nos. 6) extruder mouth piece 7) loose metallic plates & miscellaneous spares all property W/Rs. 1,88,000/- approximately belonging to the complainant.

Accused persons namely 1) Sunil Dodamanni s/o Basuraj age 18 yrs c/o Suresh Dodamanni, Corlim n/o Bagalkot Karnataka, 2) Sayad Khan s/o Javed aged 23 yrs r/o PDA Colony, Corlim n/o Karmali, Bhoma, Ponda, 3) Laudum Goyary s/o Sontla Goyary aged 24 yrs r/o Dhulapi c/o Prakash n/o Assam and 4) Jibrai Khan s/o Nabi Hussain Khan aged 25 yrs r/o c/o Shailesh Dhulapi Ilhas n/o U.P. have been arrested and stolen items mentioned at Sr. nos. 1, 2 & 4 have been recovered.

3. Bicholim Police Station

4. Porvorim P.S. Cr. No. 08/2016 U/S 454, 457, 380 IPC

On 18.01.2015, Mr. Avelino Remedious D'Souza, r/o Honey Comb Villa, Alto Porvorim, complained that from 16.01.2016 till 18.01.2016 at TNK at newly constructed bungalows namely "SINAI" and "OAK OF MEMBER" situated at PDA Colony, near Shri Niketan School, Porvorim Goa, unknown accused person/s committed theft of plumbing materials i.e. taps, mixers, shower, mixers, diverters, stop cork, angle stop cork all of Jaguar" make, and electrical wires, electrical plates all W/Rs. 1,75,000/- approx. by break opening the latch of the main door of his bungalow.

During the course of investigation accused lady Devi w/o Parshuram Rathod r/o Peddem, Mapusa n/o Hubli Karnataka has been arrested and stolen property has been recovered from the instance of the accused lady.

5. Porvorim P.S. Cr. No. 10/2016 u/s 7 (1) (3) of Foreigners Order Act 1948 r/w 14 of Forigners Order Act 1946

On 19.01.2016 registered complaint that from 22.12.2015 till date at flat No. F-2 c/o Abbas Shaikh, Ramnagar Betim accused person namely Mr. Mhdy Mussa Alareef s/o Hagen Mussa Alareef (Syrian National/Foreigner) age 25 yrs r/o Aleppo Maskana, near Mohanmad Abraham Alkalf School Aleppo, Syria presently r/o c/o Abbas Shaikh, Ramnagar Betim was found staying in India without valid visa or no any other travelling documents.

6. Pernem P.S. Cr. No. 11/2016 u/s 7(1)(3) of Foreigners Order 1948 & Sec 14 of Foreigners Act 1946

On 25/01/2016 at 16.10 hrs. accused foreigners Mr. IfeanyiChrestianChukwuka 28 yrs Nigerian National Holder of Passport No. A04802028 presently staying at Arambol was found staying illegally in india without valid visa. Accused arrested and place in police custody.

7. Calangute P.S. Cr. No. 11/2016 u/s 7(1)(3) of Foreigners Order 1948 & Sec 14 of Foreigners Act 1946& Sec 3(2)(a) &6 (a) of Passport Entry into India Rule 1950 & Sec 3 r/w 4 of Passport Entry Act 1920.

On 25/01/2016 at 21.45hrs at near Hotel La Lalyppo, Baga accused foreigners Mr. Onsay Mohammad Alhamid S/o MehmondAlhamid age 28 yrs. Syrian National was found staying illegally in india without valid visa and passport. Accused arrested and place in police custody

8. Calangute P.S. Cr. No. 13/2016 u/s (1) (3) of Foreigners Order Act 1948 r/w Sec 14 of Foreigners Act 1946.

On 26.01.2016, at 00.20 hrs, near St. Anthony Chapel, Calangute accused foreigner Nabil Mohammed Hamdi, age 30 yrs, Yemen National, Passport No. 04627663, valid from 27.02.2012 to 27.02.2018, Visa No. AP3770357, Valid from 06.06.2012 to 06.06.2015, was found staying illegally in India without valid visa.

Accused has been arrested and remanded Police Custody for 07 days.
