1. Calangute P.S. Cr. No. 125/2017 u/s 20 (b) (ii) (A) of NDPS Act

On 05.07.2017 at 23.30 hrs, upon reliable & sourceful information, Narcotic raid was conducted by staff of Calangute Police Station between 22.00 hrs to 22.30 hrs at near Gulmohar Resort, Porbawaddo, Calangute and accused person namely Adil Umed Ali, age 24 yrs, r/o c/o The Gulmohar Resort, Porbawaddo, Calangute, n/o Ward No. 14, Sekhawat Colony, Churu, Rajasthan was caught red handed for being possession of 19 grams Ganja W/Rs 3,000/- approximately.

6. Panaji PS Cr. No. 164/17 U/s 370 IPC and sec 3& 4 of ITP Act:

That on 27.07.2017 upon reliable & sourceful information, a raid was conducted by staff of Panaji Police Station between 00.50 hrs to 03.30 hrs at Near Sports Authority of Goa Campal, Panaji-Goa and accused Chandan Kumar S/o Parmeshwar Prasad Gupta age-38 yrs R/o Fulkaha Bazar Tola, Navabganj Anchal P.S. Dist- Araria Bihar procured girls from other state and supplying them to prospective customers over mobile phone No. 9112161192 and was caught red handed while delivering the girl for the purpose of prostitution and living on her earnings accused person namely Chandan Kumar S/o Parmeshwar Prasad Gupta age-38 yrs R/o Fulkaha Bazar Tola, Navabganj Anchal P.S. Dist- Araria Bihar arrested on 27/07/17.

7. Old Goa PS Cr. No. 93/2017 u/s 363, 376, 506 (ii) & Sec 8 (2) of Goa Children's Act & Sec 4 & 8 of POCSO Act:

On 01.07.2017, accused Nanu Atchalal Bharadwaj, age 27 yrs, r/o Calapur, St. Cruz, Tiswadi Goa, n/o U.P., has been arrested for kidnaping and raping a minor girl of St. Cruz, Tiswadi.

9. Calangute PS Cr. No. 124/17 u/s 3 (2) (a) and Sec. 6 (a) of Passport Entry into India Rules 1950, Sec. 3 & 4 of Passport Entry Act 1920 and Sec. 7 (3) (iii) of Foreigners Order 1948 and 14 of Foreigners Act 1946.

Accused namely Innocent Nwegbo Ifesinachi, Nigerian National who was residing Parra, Mapusa was found staying in Calangute-Goa, without passport and valid visa or other travel documents. The accused has been arrested on 05/07/2017 at 23.15 hrs, after observing Supreme Court guidelines.
