

3. The Written Examination shall be of 100 marks for 02 hours duration of H.S.S.C.E. level on the subjects (i) General Knowledge-25 marks (ii) General English-25 marks (iii) Mathematics-25 marks and (iv) Logical Reasoning-25 marks.

4. The candidates as per the below mentioned list shall carry with them the Call Letter and one of the photo identification proof in original to answer the Written Examination. The candidate is required to occupy the seat 01 hour before the scheduled time. The electronic devices including **Cellphone, Camera, Calculator** etc. will not be allowed in the Examination Hall. The candidate who will be late will be marked absent and will not be permitted to answer the Examination. The Call Letters to the candidates are sent by the post. The candidates who do not receive Call Letter may appear for the written Examination of the Trade at the above mentioned Date, Time and Venue.

5. The candidate shall note that the mere fact of his/her admission to the written examination does not imply that his/her candidature has been accepted by this Office.
