

The candidates for the posts of Mess Servant (as per the below list) are required to appear on the schedule date, time and place mentioned above along with original certificates/documents i.e. Birth Certificate, Certificate and marksheet of Educational Qualification of Secondary School Certificate Examination from a recognized Board/Institution or Successfully completed the course conducted by a recognized Industrial Training Institute or equivalent, in the relevant trade (passing on or before 08.11.2021), Certificate of Practical experience in the line preferably in any hotel of repute (issued on or before 08.11.2021), 15 years Residence Certificate (valid as on 08.11.2021 i.e. issued between 09.11.2018 to 08.11.2021), Certificate of Caste/Category (valid as on 08.11.2021 and issued on or before 08.11.2021) and Employment Registration Card.

3. The Call Letters to the candidates (as per the below list) are sent by the post. The candidates (as per the below list) who do not receive Call Letter shall appear for the verification of original documents at schedule date, time and place mentioned above.
