

The candidates for the posts of Stenographer (as per the below list) are required to appear on the schedule date, time and place mentioned above along with original certificates/documents i.e. Birth Certificate, Certificate and marksheet of Educational Qualification of Higher Secondary School Certificate or All India Council for Technical Education approved Diploma awarded by a recognized State Board of Technical Education or equivalent qualification from a recognized Institution (passing on or before 30.04.2021), Certificate of Computer Course (issued on or before 30.04.2021), Certificate of Speed of 100 word per minute in Short Hand and 35 words per minute in Typewriting (issued on or before 30.04.2021), 15 years Residence Certificate (valid as on 30.04.2021 i.e. issued between 01.05.2018 to 30.04.2021), Certificate of Caste/Category (valid as on 30.04.2021 and issued on or before 30.04.2021 and in case of OBC, issued between 01.05.2018 to 30.04.2021) and Employment Registration Card.

3. The Call Letters to the candidates (as per the below list) are sent by the post. The candidates (as per the below list) who do not receive Call Letter shall appear for the verification of original documents at schedule date, time and place mentioned above.
