The accused person Sachin s/o Pawan Kumar Chaudhary r/o flat No.302, Bldg, No-E, Devvashri Garden, Near corporation Bank porvorim Bardez Goa was placed under arrest on 01.09.2025. The investigation was conducted under the supervision of PI, Satish V. Padwalkar of Old Goa PS.

Brief Fact:- That on 30/08/2025, at 22.11 hours, an offence registered upon enquiry into Old Goa PS MV Accident No. 111/25, dated 28/08/2025 and upon the written complaint of Aarush Puneet Kohli, 19 yrs, Flat-12-A 18 Tower-E 13, floor, Saya Zion Near Chaar Murti Chowk Gaur City, Sector-4, Greater Noida west, Gautam Budha Nagar, UP C/o KK Birla Bits Pilani, Zuarinagar Sancoale, Goa, to the effect that on 24/08/2025, at around 18.00 hrs, between Mercedes Circle to Niyaz Restaurant, Mercedes Goa, while complainant/ rider of Aactiva scooter bearing Reg. Acting upon information generated through the Government of India launched Central Equipment Identity Register (CEIR) portal to track missing and lost mobile phones, Colvale Police Station successfully traced one Vivo IQOO mobile phone which was Stolen from Dattaprasad Petrol Pump Colvale in the month of May. The Police found the said stolen phone in possession of one Mr. Kuldeep Mahato native of Jharkhand working as a cook in one Restaurant at Mapusa. He revealed that he had purchased the said phone from one Mr. Chayyel Mondal, age 22 years, resident of Dinajpur, West Bengal, working as a waiter in the same restaurant. During enquiry, accused Mr. Chayyel Mondal admitted that said Vivo IQOO mobile phone was stolen from Colvale. Initially he was arrested upon the state complaint lodged by PSI Rohan Madgaonkar of Colvale PS as 5 stolen mobile phones were recovered from him. Subsequently, during further investigation more 8 mobile phones were recovered from his instance. Total 13 mobile phone W/Rs. 2,40,000/- approx. are recovered by the Police from the instance of accused persons.

Efforts are being made to identify his accomplices and ascertain the sources from where the remaining mobile phones were stolen. Further investigation is in progress under with ASI Anil Pilgaonkar under the overall supervision of Shri Rahul Gupta, IPS, Superintendent of Police, North, Shri Wilson Dsouza, SDPO Mapusa, and Sanjit Kandolkar PI, Colvale Police Station.

Further investigation is in progress with I.O. PSI Viraj Sawant of Mopa Airport PS.
