Good Detection

- 1. In Panaji PS Cr. No. 84/2025 U/s 103(1), 109 BNS, accused person Abdul Altaf S/o Abdul Rauf aged-25 yrs R/o- 19-2-11/45, Misri Gunj, Do Pahad Shah Wali Dargah Charminar Hyderabad Telangana arrested on 29/05/2025 at 19.49 hrs. All SC guidelines are dully observed.**

Brief Fact - That on 29/05/2025 at 11:39 hrs registered offence upon the complaint of Mr. Ambadatt Joshi s/o Balibhadra Joshi, age-54 Yrs, Occupation-Casino Manager, r/o c/o Apartment No. A-005, House of Lords, Miramar Panaji Goa N/o Basimdatta 19, Kanchanpur, Nepal to the effect that on 29/05/2025 at around 03:00 Hrs at Casino Carnival, Goa Marriott Resort and Spa, Miramar Panaji Goa accused person nansely Abdul Altaf c/o Abdul Rauf, 19-2-11/45, MisriGunj, Do Pahad Shah Wali Dargah, Charminar Hyderabad Telangana assaulted the security personnel namely Satyam Gaonkar on his head with wooden piece of the hand railing with intention to kill him and also assaulted security personnel namely Dheeru Sharma on his face and head region with the said hand railing and killed him.

- 2. In Porvorim PS Cr. No. 44/2025 u/s 336(1), 336(2), 336(3), 338, 340(2), 318 BNS, accused persons namely 1) Rabin s/o Lakshikanta Paul, age 41 years, r/o Baluigachi, Laxmipul, Habra-I, North 24 Parganas, West Bengal arrested on 18.05.2025. 2) Purnashish Sana s/o. Shyamsundar Sana, age: 47 years, r/o. 17/H/14, 2nd floor, Sukhdeb Bhavan, Chaulpatty Road, Beliaghata, Kolkata, native of Kamalpur, Howrah, West Bengal were arrested on 27.05.2025 at 20.47 hrs. All SC guidelines are dully observed.**

Brief Fact - That on 06/05/2025 at 00.44 hrs registered an offence upon the complaint of Dr. S.S. Ghadi, State Project Director, Goa Samagra Shiksha, ,1st floor, Directorate of Education, Porvorim-Goa to the effect that between 21.02.2025 to 05.03.2025 at Porvorim an unknown accused person/s, prepared forged cheques of Bank of India, Porvorim Branch issued to Goa Samagra Shiksha, Govt of Goa. Further the said forged cheques were presented before different banks as genuine one and made different transactions and withdrawn total amount of Rs. Rs.5,36,03,000/-(Rupees Five Crores Thirty six lakhs, three thousand only) from saving Bank Account bearing No. 100810110002024 of Goa Sarva Shiksha Abhiyan Society maintained at Bank of India, Porvorim branch, thereby cheated the complainant.

- 4. In Old Goa PS Cr. No. 65/2025 U/S 137(2) BNS and Sec 8 of Goa Children's Act 2003, minor victim, who is grand daughter of complainant has been traced.**

5. In Mapusa PS Cr. No. 76/25 U/s 137(2) of BNS & sec 8 of G. C. Act, minor victim, who is son of complainant has been traced.
6. In Bicholim PS Cr. No. 23/2025 u/s 137 (2) BNS and 8 of Goa Children's Act. Section 64, 65(1) of BNS and Sec.4,8 of POCSO Act, minor victim daughter of complainant has been traced at Muzaffapur Bihar Stat and accused Sandesh s/o Devendra Mukhiya, aged 23 years r/o Ektanagar, Sarvan Bicholim was brought brought at Bicholim Police Station on transit remand and produced before JMFC Bicholim on 18.05.2025.
7. In Mandrem PS Cr No: 53/2025 U/s 7(1) (3) of Foreigners Order 1948 and Section- 14 of Foreigners Act-1946, accused foreigner Roman s/o Viadislav Loskutov, Age: 35 yrs, Nationality: Russian have been arrested on 10.05.25 at 15.49 hrs who was found illegally staying in India without valid travel documents. All SC guidelines are dully observed.

In Mandrem PS Cr No: 54/2025 U/s 7(1) (3) of Foreigners Order 1948 and Section- 14 of Foreigners Act-1946, accused foreigner Ms. Valentina s/o Sergey Bokhan, age: 33 yrs, Nationality: Russian have been arrested on 10.05.25 who was found illegally staying in India without valid travel documents. All SC guidelines are dully observed.

In Mandrem PS Cr No: 55/2025 U/s 7(1) (3) of Foreigners Order 1948 and Section- 14 of Foreigners Act-1946, accused foreigner Dawid Wierzbowski, age- 47 yrs, National of Republic of Poland have been arrested on 10.05.25 who was found illegally staying in India without valid travel documents. All SC guidelines are dully observed.

Narcotic Drugs seizure in NDPS CASES

1. Anjuna PS Cr. No. 85/2025 U/s 20(b)(ii)(B) of NDPS Act

That on 16.05.2025 at 21.12 registered offence upon the state complaint of Shri Sahil V. Warang, PSI Anjuna Police Station to the effect that on 16.05.25 between 17.30 hrs to 19.30 hrs at near football ground Piquen Peddem Anjuna Bardez Goa, upon specific and reliable information narcotic raid was conducted wherein accused Anil s/o Het Ram Kumar, age 26 yrs r/o Village- Gujar Ka Ropru, PO- Samrahan, Tehsil- Kotli, Dist- Mandi Himachal Pradesh was found with illegal possession of black colour Sticky Substance suspected to be Narcotic Drug "Charas" weighing 182 grams W/Rs. 1,82,000/- appox. Which was concealed in black colour waist bag. The said illegal suspected drugs along with other exhibits has been seized under the search panchanama after following all mandatory provisions of NDPS Act 1985.

Accused Anil s/o Het Ram Kumar, age 26 yrs r/o Village- Gujar Ka Ropru, PO- Samrahan, Tehsil- Kotli, Dist- Mandi Himachal Pradesh has been arrested on 16.05.2025 at 21.12 hrs. All SC guidelines are dully observed.

2. Anjuna PS Cr. No. 86/2025 U/s 22 (b), 21 (b) of NDPS Act.

That on 17.05.2025 at 01.05 registered offence upon the state complaint of Shri Viraj Naik, PSI Anjuna Police Station to the effect that on 16.05.25 Bet. 19.45 hrs to 23.30 hrs at near St, Cajetan Church Assagao Bardez Goa upon specific and reliable information narcotic raid was conducted wherein accused Santosh s/o Nemappa Lamani age 24 yrs r/o Hno.169/2, Soranto Waddo Anjuna Bardez Goa n/o Karnataka was found illegal possession of 09.49 grams suspected psychotropic drugs known as "MDMA Rs. 1,60,000/- and 04.46 grams of suspected psychotropic drug known as "Cocaine" Rs. 50,000/- having all together value Rs.2,10,000/- approx. Which was found in one light blue & grey colour school bag found in the possession of above accused person. The said illegal suspected drugs along with other exhibits has been seized under the search panchanama after following all mandatory provisions of NDPS Act 1985.

Accused Santosh s/o Nemappa Lamani, age 24 yrs r/o Hno.169/2, Soranto Waddo Anjuna Bardez Goa n/o Karnataka has been arrested on 17.05.2025 at 01.05 hrs. All SC guidelines are dully observed.

4. Mapusa PS Cr. No. 72/25 u/s 20 (b) (ii) (A) of NDPS Act
