### Good Detection

1. **In a Murder case of Mapusa PS Cr. No. 103/25 U/Sec. 103 (1) R/w 3 (5) of Bharatiya Nyaya Sanhita 2023**, accused persons namely 1) Sattya Nabarangpuria., 50 Yrs R/o. Fondac wada, Parra Bardez N/o. Khaliakain Amurlapadar, Kalahandi, Odisha and 2) Thabir S/o Sattya Nabarangpuria. 31 Yrs R/o. Fondac wada, Parra Bardez N/o. Khaliakain Amurlapadar, Kalahandi, Odisha **were** arrested on 08.07.25 at 13.46 hrs. All SC guidelines are dully observed. Weapon used in case was recovered 1) Iron Rod and 2) Knife.

Brief Fact - That on 08.07.25 at 04.43 hrs Complainant Mr. Vijay Yashwonth Naik, 20 years, R/o of Bastora, Bardez, Goa, N/o Surendra Gauda Camp, Siddilipura, Holehonnur, Bhadravathi, Shivamogga, Karnataka lodge his complaint to the effect that on 07.07.25 at about 21.00 hrs at Temporary hut, under construction site, Fondacwado, Parra, Bardez, Goa accused person 1.Mr. Sattya 2. Mr. Thabir S/o Sattya Both N/o Odisha with their Common intention committed the Murder of the (Dropada Tularam Naik, 30 Yrs) who is Nephew of accused No.1, by brutally assaulting him with deadly weapons specifically targeting his vital parts thereby causing his death.

2. **In a Attempt to murder case of Calangute PS Cr. No. 109/2025 U/s 109 (2) of Bharatiya Nyaya Sanhita 2023**, accused Arun Pawar s/o Shankar Pawar, age-26 yrs r/o Colva Margao n/o Adisumapur, tanda Gadag arrested on 15.07.2025 and accused Parshuram s/o Alapm Karabhari, age-28 yrs r/o Advisomapur, Gadag, Karnataka has been arrested on 17.07.2025.

Brief Fact:On 13/07/2025 at 12.18 hrs registered Calangute P.S. Cr. No., upon complainant Shri Akash Thavreppa Lamani, age 22 years r/o J. J. Bakery, Khobra waddo, Calangute to the effect that on 13/07/2025 at about 00.30 hrs at near J.J Bakery, Khobra wado, Calangute, Bardez, Goa, accused person namely Akash Lamani, age about 26 years r/o Near La Calypso Hotel, Baga, Calangute, Goa n/o Balaji Nagar, Gadag, Karnataka over the issue of money relating to tattoo business assaulted the friend of the complainant namely Arun Lamani, age about 23 years r/o Near La Calypso Hotel, Baga, Calangute, Goa with pen knife and attempt to commit murder, thereby causing grievous bodily injuries over his face and left side abdomen area.

No- 32/1, Church Colony, Neura, Azossim N/o Soe Semar Toli, Soe Simdega, Jharkhand and 2) Manish Sio Jai Vishun Singh, Age- 19 yrs, R/o C/o Azossim N/o Village- Unikel, Post-Bano, P.S Baano, Simdega, Jharkhand were arrested on 06/07/2025 at 03.51 hrs. All SC guidelines are dully observed.
- Brief Fact** – That on 04/07/2025 at 19:32 hrs upon the complaint of Mrs. Reena Devi W/o Ranjit Lohra, Age 31 yrs R/o H.No.27/B, Azossim, Tiswadi Goa N/o Bano Simdega, Jarkhand, lodged to the effect that on 03/07/2025 at 16.00 hrs. at Azossim, Tiswadi Goa unknown accused person/s Kidnapped the minor daughter of the complainant, Age-13years, from her lawful guardianship without her consent and took her to unknown destination.
4. **In a Murder case of Bicholim PS Cr. No.102/2025u/s 103 BNS, 2023 and sec. 3 r/w 27 of Arms Act, 1959**, accused Khajaminudin Nazeershab Havangi, aged 28 years, R/o: Vathadev, Sarvan, Bicholim, N/o: Karnataka has been arrested on 25/07/2025 at 23.58 hrs after explaining him the grounds of his arrest & all arrest formalities has been observed as per Supreme Court.

The motive behind the crime is that the accused person had grudges against the victim i.e. his wife due to their separation since last 4 to 5 months.

## Narcotic Drugs seizure in NDPS CASES

### **1. Calangute PS Cr. No. 105/2025 U/s 20 (b) (ii) (A) of NDPS Act 1985**

on 03.07.2025 at 19.05 hours upon the State complaint of Shri. Yogesh Mandrekar, Police Sub Inspector, Calangute Police Station registered to the effect that on 03.07.2025 between 16.20 hrs to 18.00 hrs at near HP Gas godown, Naikawado, Calangute, Bardez-Goa a narcotic raid was conducted and during the search caught accused persons Mr. Anil Jena s/o Basanta Jena, age- 21 yrs, R/o Gunapur, Baliapal, Baleswar Odisha, for being in illegal possession of in possession of 510 grams of greenish colour leafy flowery tops substance suspected to be Ganja W/Rs 50,000/- approx, which is attached under Search & Seizure Panchanama.

Accused person Anil Jena s/o Basanta Jena, age- 21 yrs, R/o Gunapur, Baliapal, Baleswar Odisha has been arrested on 03.07.2025 at 20.04 hours and lodged in PS lock up. All SC guidelines dully observed. Further investigation is in progress with PSI Dinesh Kanokar of Calangute PS.

GA11J7932 which is attached under search and seizure Panchanama along with other exhibits.

Accused Manish Rathore s/o Bhoopal Singh, has been arrested on 19/07/2025. All SC guidelines are dully observed.
